Subject: Award of annual contract for repair/supply of electric boards/ Emergency lights/ electric bell/ table lamp/ tube light fittings/ hot case/ electric blowers/ heaters & miscellaneous electrical etc. regarding.

I am directed to say that the Commission for Agricultural Cost and Prices intends to award the annual maintenance and service contract for repair / supply of electric boards/Emergency lights/electric bell/ table lamp/ tube light fittings/hot case/electric blowers/heaters & miscellaneous electrical etc.. The list of electrical items / Work to be done is mentioned in the Annexure – I. The terms and conditions would be as under:-

1. The period of contract will be one year.
2. The Contractor will be required to contact the Commission for Agricultural Cost and Prices every day to take orders for repair and maintenance and supply with those orders on urgent basis.
3. The Contractor will supply/install only ISI marked electrical items. Failure to supply/install ISI marked electrical items converted under the contract would make the contract liable to be terminated without notice.
4. The Commission for Agricultural Costs and Prices reserves the right to reject any/all quotations.
5. The job of maintenance and service which is generally of urgent nature would be done in the Commission for Agricultural Cost and Prices. If any item has to be taken from the Commission for Agricultural Cost and Prices for repairing, the contractor would have to bear the expenses. No extra charges would be given for that.
6. If at any stage, the services of the firm are not found satisfactory or the firm has failed to provide services and rectify the defect within 24 hours the AMC will liable to be terminated by the Commission for Agricultural Cost and Prices without assigning any reason, whatsoever. In case of such termination, no payment would be made and payment made, if any, would be deducted from Security.

7. The tenderer/firm will be required to furnish a demand draft of Rs. 3,000/- in favour of Pay and Accounts Officer, Commission for Agricultural Cost and Prices at the time of sending the quotations which will be returned to them if they are not awarded the contract.
8. The successful tenderer will be required to furnish a demand draft of Rs. 5,000/- as performance security in the name of Pay and Accounts Officer, Commission for Agricultural Cost and Prices at the time of award of the contract which will be released to the contractor on satisfactory completion of the contract.

Accordingly, interested firms may send their quotation in sealed covers along with demand draft of Rs. 3,000/- in favour of D. D. O., Commission for Agricultural Cost and Prices to the Administrative Officer, Commission for Agricultural Cost and Prices, R. No. 217, 'F' Wing, **Shastri Bhawan, New Delhi by hand or by post latest by 11.30 A.M. 16th May, 2022**. The quotations will be opened on the same day at 2.30 P.M. in the room of the undersigned in the presence of the representatives of the firms, if any. The envelope containing the quotation shall be superscribed as "Quotation for providing Electrician for repairing work of minor electrical appliances"
